2018/2019 USA GYMNASTICS FOREIGN ATHLETES, COACHES & JUDGES

\$50

The Foreign Athletes, Coaches and Judges application and applicable fees must be submitted for anyone that is a non-U.S. citizen who resides outside of the United States and intends to participate in a Foreign Sanction event as an athlete, coach or judge. The cost for non-U.S. athletes, coaches and judges is \$50 (USD) per participant. This is for insurance purposes only. They will not receive any other membership benefits.

Application must be submitted no later than forty-five (45) days before the meet or competition. All USA Gymnastics inter-club competitions follow FIG guidelines, and require federation to federation approval before foreign sanctioning and foreign participant memberships are processed. Memberships will be given only to those individuals that are registered for foreign sanctioned events. This form must be filled out completely for processing.

Foreign Athlete, Coach and Judges are eligible to participate in Foreign Sanctioned events ONLY. Foreign Athlete, Coach and Judges are not permitted to participate in Domestic Sanctioned events.
